

### **Mekanisme Penyaluran Pupuk Bersubsidi/Pupuk PSO**

PI Grup memiliki penugasan untuk menyalurkan dan mendistribusikan pupuk bersubsidi atau pupuk *Public Service Obligation* (PSO). Hal itu sesuai dengan Peraturan Menteri Perdagangan No. 15/M-DAG/PER/4/2013 tanggal 1 April 2013 tentang Pengadaan dan Penyaluran Pupuk Bersubsidi untuk Sektor Pertanian.

Berdasarkan peraturan tersebut, kewajiban yang diemban Perusahaan adalah:

1. Wajib menjamin ketersediaan stok pupuk bersubsidi di Lini III paling sedikit untuk kebutuhan selama 2 (dua) minggu ke depan sesuai dengan rencana kebutuhan pupuk bersubsidi dalam negeri yang ditetapkan dengan Peraturan Menteri;
2. Wajib menjamin ketersediaan stok pupuk bersubsidi di Lini III paling sedikit untuk kebutuhan selama 3 (tiga) minggu ke depan sesuai dengan rencana kebutuhan pupuk bersubsidi dalam negeri yang ditetapkan dengan Peraturan Menteri pada setiap puncak musim tanam bulan November hingga Januari;
3. Distributor wajib menjamin ketersediaan stok pupuk bersubsidi di wilayah yang menjadi tanggung jawabnya paling sedikit untuk kebutuhan 2 (dua) minggu ke depan sesuai dengan rencana kebutuhan pupuk bersubsidi yang ditetapkan dengan Peraturan Bupati/Walikota setempat;
4. Pengecer wajib memiliki persediaan stok pupuk bersubsidi paling sedikit untuk kebutuhan 1 (satu) minggu ke depan sesuai dengan RDKK di wilayah yang menjadi tanggung jawabnya.

Perusahaan mengatur pengadaan dan pendistribusian pupuk bersubsidi di dalam negeri untuk sektor pertanian secara nasional, mulai dari Lini I sampai dengan Lini IV sesuai dengan prinsip “6 (Enam) Tepat”: Tepat Jenis, Jumlah, Harga, Tempat, Waktu dan Mutu. Mekanisme dan pola distribusi pupuk bersubsidi dapat dilihat pada bagan di bawah ini.

### **Subsidized Fertilizer/PSO Fertilizer Distribution Mechanism**

PI Group has been assigned to channel and distribute subsidized fertilizer called Public Service Obligation (PSO) fertilizer. This is in accordance with the Minister of Trade Regulation No. 15/M-DAG/PER/4/2013 dated April 1, 2013 concerning the Procurement and Distribution of Subsidized Fertilizers for the Agricultural Sector.

Based on these regulations, the Company's obligations are:

1. Mandatory guarantee of the availability of subsidized fertilizer stock in Line III at least to cover the needs for the next 2 (two) weeks, in accordance with the plan for domestic subsidized fertilizer needs stipulated by a Ministerial Regulation.
2. Mandatory guarantee of the availability of subsidized fertilizer stock in Line III at least to cover the needs for the next 3 (three) weeks, in accordance with the plan for domestic subsidized fertilizer needs stipulated by a Ministerial Regulation at the peak of each planting season from November to January.
3. Distributors are required to guarantee the availability of subsidized fertilizer stocks in the areas under their responsibility for at least the next 2 (two) weeks in accordance with the plan for subsidized fertilizer needs stipulated by the local Regent/Mayor Regulation.
4. Retailers are required to maintain a stock of subsidized fertilizer to cover at least for the needs of the next 1 (one) week in accordance with the RDKK in the areas they are responsible for.

The Company regulates the procurement and distribution of subsidized fertilizers domestically for the agricultural sector nationally, starting from Line I to Line IV in accordance with the “6 (Six) Right” principle: Right Type, Quantity, Price, Place, Time and Quality. The mechanism and pattern of distribution of subsidized fertilizer can be seen in the chart below.
